

STARBUCKS SHARE THE CHEER SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Starbucks Share The Cheer Sweepstakes ("Sweepstakes") is sponsored by Starbucks Corporation, 2401 Utah Avenue S., Suite 800, Seattle, WA 98134 ("Sponsor"), and is administered by Prize Logic, LLC, 25200 Telegraph Road, Suite 405, Southfield, MI 48033 ("Administrator").

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on September 25, 2017 at approximately 12:00 PM Eastern Time ("ET") and ends on December 31, 2017 at approximately 11:59:59 PM ET ("Sweepstakes Period") and consists of four (4) entry periods (each an "Entry Period") as outlined in the chart below:

Non-winning entries will carry forward into subsequent Entry Period drawings. The Administrator's computer is the Sweepstakes official clock.

- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, contractors or development, production, marketing or distribution of Sweepstakes materials, including without limitation, any prizing element, and their respective parent, affiliated, and subsidiary entities and advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their respective immediate family members (i.e., spouse, parent, child, sibling and the "steps" of each) and persons living in the same household of each are not eligible to participate in the Sweepstakes. - 3. HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant may visit <https://Cheer.Starbucks.com> ("Website") and complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, zip code and create a password. Once an entrant has registered or logged in, he/she may earn Sweepstakes entries via the following methods:

A. Make A Purchase: During the Sweepstakes Period, an eligible entrant may purchase any three (3) packages of Starbucks® packaged coffee (10 oz. or larger), Starbucks® or Tazo® K-Cup® packs (6 ct. or larger), Starbucks VIA® Instant Coffee (5 ct. or larger), Tazo® Tea Filterbags or Tazo® Tea Latte Concentrates, Frappuccino® Chilled Coffee Drink (4-pack), Starbucks Doubleshot® Drinks (4-pack), Starbucks® Hot Cocoa (8-pack), in a single transaction ("Qualifying Purchase"), while supplies last, at a participating store. Purchases at Starbucks stores do not qualify. Entrant then must visit the Website and follow the links and instructions to upload a photograph of the original register receipt showing the Qualifying Purchase. The file must be in .JPEG, .JPG, .PNG, or .GIF format (no PDFs will be accepted) and may not exceed 5 MB. Following this method of entry, an entrant will receive two (2) entries into the applicable Entry Period for one (1) receipt upload. There is a limit of ten (10) receipt uploads during the entire Sweepstakes Period.

i. Mail-In: To enter the Sweepstakes without making a purchase, an entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, and telephone number on a 3½"x5" card ("Mail-In Entry") and mail it (without an outer mailing envelope) with sufficient postage to Starbucks Share The Cheer Sweepstakes, PO Box 251328, West Bloomfield, MI 48325. Entrant will earn two (2) entries into the respective Entry Period. Each Mail-In Entry is worth two (2) entries and there is a limit of ten (10) Mail-Ins during the entire Sweepstakes Period. All Mail-In Entries must be postmarked by and received by the dates indicated in the chart above in Section 1. Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, Mail-In Entries sent in excess of the entry limits set forth herein will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

B. Create A Game Board: During the Sweepstakes Period, an eligible entrant may complete a game board ("Game Board"). To complete a Game Board, each entrant must select six (6) holiday moment categories (each a "Category") from the Categories provided. Each Game Board must include one (1) Category from the "Implied Purchase Moments Options" and five (5) Categories from the "Holiday Moments Options." Once an entrant selects the Categories for his/her Game Board, an entrant may upload a photo that meets the holiday moment Category's description or theme. Entrants may upload his/her photos to the Website by clicking the upload photo button.

Each Category may only be used one (1) time during the Sweepstakes Period. An entrant will receive one (1) Sweepstakes entry into the applicable Entry Period once a Game Board is completed. Entrants may submit a total of three (3) complete Game Boards for a total of three (3) Sweepstakes entries. If more than the stated number of entries are received from the same person, telephone number and/or e-mail address during a day, the entries may, at the Sponsor's sole discretion, be disqualified.

By submitting a photo each entrant hereby agrees to the terms and conditions set forth in these Official Rules and each entrant agrees that his/her photo entry conforms to the photo entry guidelines and restrictions set forth below ("Entry Guidelines and Restrictions"). Each entrant hereby acknowledges that such entrant does not reserve any rights in or to the photo entry. The displaying of a photo entry on any website/social media platform does not constitute verification of eligibility or compliance with these Official Rules and all entries and entrants remain subject to verification of eligibility and compliance with these Official Rules as determined by Sponsor at its sole discretion.

Entrants agree that Sponsor has the right, but not the obligation, to use and/or otherwise display the entries as set forth above, and that if such entries are, in Sponsor's sole discretion, displayed on any website/social media platform, such entries may be subject to third party comments that will be publicly viewable, and further, such entries may also be saved, shared, and/or further e-mailed by such third parties on the internet or otherwise.

- Must not contain material or statements that promote use of alcohol by minors, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing), any activities that may appear unsafe or dangerous, or any particular political agenda or message;

i. **Mail-In Alternate Method Of Entry:** To enter the Sweepstakes without creating a game board, an entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Entrant will receive one (1) entry into the respective Entry Period. Each Game Board Mail-In Entry is worth one (1) entry and there is a limit of three (3) Game Board Mail-Ins during the entire Sweepstakes Period. All Game Board Mail-In Entries must be postmarked by and received by the dates indicated in the chart above in

Section 1. Game Board Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, Game Board Mail-In Entries sent in excess of the entry limits set forth herein will not be accepted. Game Board Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries

Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

 - A. Prizes (500; one hundred twenty-five [125] per Entry Period).** Each winner will receive a \$300 limited edition Sterling Silver Starbucks Card ("Prize"). The ARV of each Prize is \$450 (the value of the Sterling Silver card itself is \$150 and \$300 will be loaded onto it). The use of the Starbucks Card is subject to the terms and conditions set forth thereon. The Prize will not be redeemed or exchanged for cash, except where required by law. The Prize will not be replaced or replenished if it lost, stolen, damaged, destroyed or used without the winner's permission and will be voided if altered or defaced. There will be not more than five hundred (500) Prizes available in this Sweepstakes.
 - B. Total ARV:** The total ARV of all available Prizes in this Sweepstakes is \$225,000.
 - C. Odds of Winning:** The odds of winning a Prize depend on the total number of eligible entries received during each respective Entry Period.

compliance with these Official Rules. After each random drawing, Administrator will notify each potential winner via e-mail at the e-mail address provided at the time of registration. Upon verification of eligibility and receipt of signed documents, each Prize will be mailed to the winner at the physical address (P.O. Boxes not permitted) provided during winner verification or at the time of entry. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept a Prize, the respective Prize may be forfeited. If a Prize is forfeited, the Prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible entries, as determined by Sponsor in its sole discretion. If, after a good-faith attempt, Sponsor is unable to award or deliver a Prize, the Prize may not be awarded.

10. **PUBLICITY RIGHTS:** By participating in the Sweepstakes and/or accepting a Prize, each entrant agrees to allow Sponsor and Sponsor's designee the perpetual right to use his/her name, biographical information, photos and likeness, voice recording, video images and all related footage, and statements for Sweepstakes, trade, commercial, advertising and publicity purposes, at any time or times, in all media now known or hereafter discovered worldwide, including but not limited to television (including live television), radio, and Internet, without notice, review or approval and without additional compensation except where prohibited by law.
